**MINUTES OF SELECTMEN'S MEETING
May 4, 2006**

Present: David Putnam, & Wesley Staples. Elaine Moore was not present.

David Putnam called the meeting to order at 7:00 PM.

PUBLIC BUSINESS:

Susie Harris: Susie Harris was in to discuss getting the tennis court on Glebe road resurfaced due to a large crack that goes down the center of the court. Susie stated that the estimate that she has is for \$3,998.00. David Putnam stated that the Town did not budget this cost in with the original budget so there are no funds available to pay for the resurfacing. There is a recreation fund that can be used to pay for a portion of the cost, but Susie Harris will need to find the rest of the cost from other parties.

Jan Carpenter: Jan Carpenter was in to discuss the Moose Grant for the Historical Society with the Selectmen. She wanted to get the Selectmen's approval that they will sign for the Moose Grant that the Historical Society is applying for. The Selectmen agreed to sign with the Historical Society for the Moose Grant.
